# Charitable Giving Policy

---

Here at Cision, we recognize that our employees have a wonderful tradition of giving back.

To encourage and reward these efforts, Cision's Charitable Giving program allows eligible employees to continue contributing to causes they care the most about. The program will double the impact of their charitable donations to eligible nonprofits with matching gifts up to USD 200 (or the global currency equivalent of USD 200) per employee, per calendar year.

# Program Rules

**Eligible Charitable Organizations:** Charitable organizations must be a community-led non-profit or tax-exempt under section 501(c)(3) of the Internal Revenue Code. (Further information regarding 501©(3) designations can be found on the Internal Revenue Service’s Website.)

## Eligibility

---

Cision’s Charitable Giving Program is subject to employee eligibility and IRS rules and regulations which include the following:

- The employee must be an active regular, full-time employee of Cision.
- The employee has donated via the THRIVE platform to an eligible 501©(3) organization.
- The employee has not reached their annual charitable giving maximum match of \$200 USD (or the currency equivalent of \$200 USD globally).

## Ineligibility

---

- Religious organizations: religious programs or organizations whose principal purpose is to promote a particular religious faith, creed, or doctrine (e.g. missions, religious orders, etc.)
- Discriminatory organizations: Cision will not match contributions to any organization that discriminates based on race, religion, national origin, citizenship, gender, sexual orientation, marital status, disability, or any other classification protected by law.
- Lobbying/Advocacy: Cision will not match contributions to political causes or candidates, organizations associated with fraternities, sororities, their affiliated foundations, political organizations, lobbying groups, or individuals.
- Personal gain: We do not match charitable gifts that provide benefits directly to employees or their families, such as trips, tours, internships, tuition, event tickets, parking privileges, club dues, products, and services, or discounts on products or services.


# Program Rules

## Matching process

---

Eligible employees can directly contribute via credit card to eligible organizations of their choice through the THRIVE platform. Donations made by eligible employees through THRIVE will be matched systematically once a donation is made.

while there is no limit on the amount that the employee can contribute to eligible organizations, Cision will only match up to USD 200 (or the global currency equivalent of USD 200) annually.
